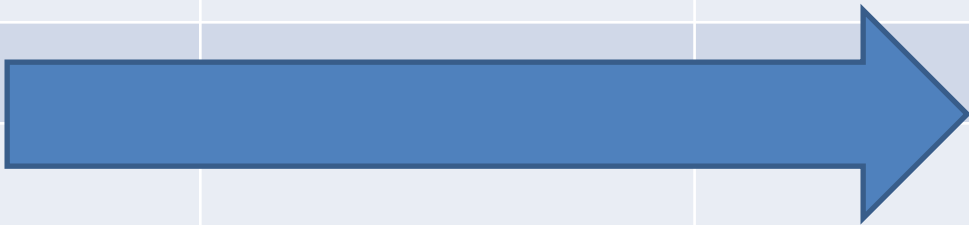
Overview of 2020.

The year 2020 was very different, but despite the pandemic our Chamber **remained positive, adapted quickly to the new reality and kept the highest standard of business events.**

- Last year we organised **14 events**: 2 business delegations, 2 live, 2 hybrid and 8 online events. Our online and hybrid events were also streamed through Slovenian Press Agency's platforms and we got additional attention from viewers and journalists (on **average 200-300 live views** per event).
- We joined the initiative **Gospodarski krog** at the beginning of the first wave of the pandemic. The initiative was formed in cooperation with Manager's Association of Slovenia, GZS, Slovenian Business Club, German-Slovene Chamber of Commerce and AmCham where business organisations joined forces to share opinion, expertise & connections during various occasions.
- We established an **FDI committee**, where the aim is to eliminate market access barriers in Slovenia. Members of the committee are foreign investors in Slovenia, and members of our chamber.
- We're also providing the **British Embassy Ljubljana** with the support in the fields of trade, bilateral economic cooperation and investment.
